Mr. Montino, Jr. is an accomplished data and technology executive with over 20 years of experience leading digital transformation across banking, retail, and telecommunications. He previously served as Chief Data Officer at UnionBank and held key roles at Terradata and SM Retail—as Ecosystem Architect and Head of Business Intelligence and Data Warehouse, respectively. He joined Globe Telecom after completing his bachelor's degree.

Mr. Montino, Jr. completed his degree in Information Technology from the University of Santo Tomas in 2005.

The Bank's Board of Directors, in its meeting on July 31, has regrettfully accepted the resignation of Mr. Lawrence L. Lee, Executive Vice President and Head of Consumer Lending, effective August 21, 2025.

Mr. Lee is stepping down to spend more time with his family in Singapore. The Board expressed its appreciation for Mr. Lee's leadership and contributions to the Bank.

In line with the Bank's established succession plan, leadership continuity in the Consumer Lending Group has been secured, with arrangements already in place to ensure smooth and uninterrupted operations.
